### Explanatory notes about the Parliamentary Network on Climate Change - ParlAmericas

The Executive Committee of the Parliamentary Network on Climate Change will be composed of a President and four Vice-Presidents (one for each sub-region listed below) that will be individually elected for a **two (2) year** period, with the opportunity for re-election.

- **North America:** Canada, Mexico and United States
- **Central America:** Belize, Costa Rica, El Salvador, Guatemala, Honduras, Nicaragua and Panama
- **Caribbean:** Antigua and Barbuda, The Bahamas, Barbados, Cuba, Dominica, Dominican Republic, Grenada, Haiti, Jamaica, Saint Kitts and Nevis, Saint Lucia, Saint Vincent and the Grenadines and Trinidad and Tobago
- **South America:** Argentina, Bolivia, Brazil, Chile, Colombia, Ecuador, Guyana, Paraguay, Peru, Suriname, Uruguay and Venezuela

The President of the Parliamentary Network on Climate Change - ParlAmericas is also the 2<sup>nd</sup> Vice-President of the Board of Directors of ParlAmericas.

The elections will take place at the Gatherings of the Parliamentary Network on Climate Change. The parliamentary delegation from each country in attendance of the gathering may vote for the President and each of the sub-regional Vice-Presidents.

Parliamentarians wishing to submit their candidacy must be active members of their respective national legislatures and cannot simultaneously hold office as a Cabinet minister in the executive branch of her/his government.
