CARLOS J. DE MIGUEL is the head of the Policies for Sustainable Development Unit of the Division of Sustainable Development and Human Settlements at the United Nations Economic Commission for Latin America and the Caribbean (ECLAC). He coordinates ECLAC’s support for the implementation of Rio+20 outcomes, including the Principle 10 regional process and the post-2015 development agenda. Mr. de Miguel also prepares economic quantitative assessments of public policies and environmental performance reviews, and he leads economic studies of climate change in Latin America and the Caribbean. He is an economist with a master’s degree in Environmental Economics (Chile), a post-graduate degree in European Studies (Netherlands), and a PhD in Economic Analysis (Spain). He has co-authored numerous books, journals, and working papers on sustainable development, trade, macroeconomics, finance, poverty, energy, environment, and climate change.

CLAUDIA DE WINDT is a Senior Legal Specialist in the Department of Sustainable Development of the Organization of American States (OAS-DSD), where she leads the environmental law, policy, and good governance section. She currently focuses on capacity building efforts in the areas of trade and sustainable development, environmental law and enforcement, access to information, to justice and participation.
