#### **Visas:**

All travelers must have a valid passport and, in some cases, a [visa to enter Colombia](#). All participants are responsible for confirming with their respective consular authorities regarding whether they require a visa or any other entry documents for Colombia and/or any other transiting countries.

#### **Preferential rate:**

- Business Suite: \$209,900 Colombian Pesos /night
- Deluxe Suite: \$249,900 Colombian Pesos /night
- Master Suite: \$289,900 Colombian Pesos /night

#### **Hotel Policy:**

- Check-in: 15:00 / Check-out: 12:00
- Requests for early check-in or late check-out (50% of the rate) will apply.
- Individual cancellation policy: 72 hours before check-in.

#### **Transportation:**

Transportation between the airport and the official hotel will be offered and organized by the Tequendama Suites and Hotel. Transportation can be arranged directly with the hotel reservations staff. The rates are:

- TRUCK (CAPACITY 3 PEOPLE) \$85,800 Colombian Pesos
- VAN (CAPACITY 9 PEOPLE) \$171,600 Colombian Pesos

#### **Health Insurance:**

All participants are advised to obtain health insurance.

#### **Currency:**

The national currency of Colombia is the Colombian Peso and is represented by COP. Foreign currency exchange can be done at most banks and exchange offices located at the airport and in most shopping malls. The official exchange rate is approximately \$4503.99 COP per \$1 USD (US dollar).

#### **Electricity:**

The electricity supply in Colombia is 110 volts, 60 Hertz of alternating current.

### **Travel Restrictions Information – COVID-19:**

Travelers of any nationality entering by air:

1. Report your health status through the [Check-Mig form](https://apps.migracioncolombia.gov.co/pre-registro/public/preregistro.jsf), 24 hours before the flight, online:  
<https://apps.migracioncolombia.gov.co/pre-registro/public/preregistro.jsf>
2. Submit the vaccination card\*\* with a complete vaccination schedule (double vaccinated) that demonstrates having completed the vaccination schedule within 14 days prior to travel, or submit a negative PCR test done no more than 72 hours before travel, or an negative antigen test done no more than 48 hours before travel.
3. Do not travel if you have symptoms associated with COVID-19, if you were in close contact with a positive case, or if you have been diagnosed positive for COVID-19 in the last 14 days.
