10:15 – 12:00 **Session 1: International Climate Action and the role of National Parliaments**

In this session, the key themes and the foreseen milestones of the climate negotiation process will be discussed, such as the implementation manual for the Paris Agreement, the stocktaking events and the second round of the Nationally Determined Contributions (NDCs). The aforementioned will be accomplished with the purpose to better understand the obstacles and opportunities for National Parliaments to assist their countries in the implementation of the climate targets found within their NDCs by 2030.

13:00 – 14:30 **Session 2: The socio-economic challenges and opportunities of limiting global temperature increase to 1.5 degrees Celsius**

The achievement of the climate goals will require transformational changes within governments, businesses, municipalities, financial entities, labour organisations, researchers and innovators and individuals. 14:30 – 15:30 **Session 3: Loss and Damage in the Americas and Caribbean: Beyond adaptation**

The unavoidable damages caused by human-induced climate change, which go beyond adaptation, are known as “loss and damage”. In the Paris Agreement, developed countries agreed to include loss and damage, however with the clarification that it “does not involve or provide a basis for any liability or compensation”.

This session will present the central debates in the climate negotiations and discuss the political-legislative perspective of the mechanisms to transfer risks and climate-proof national economies in the face of projected climate impacts that go beyond current adaptation capacities.

Interactive Report: Parliamentarian Contribution to the Climate Agenda



This session will permit an interchange between parliamentarians and climate experts from different international organizations, promoting dialogue on the various aspects of the climate agenda, through the knowledge and experiences of the legislators. Participants will seek to identify concrete opportunities and priorities to advance the climate agenda at the national and regional level on different issues, in their respective countries. An innovative methodology will be used to facilitate an interactive reporting of the major conclusions to the plenary.

Session 4: Carbon Pricing in the Americas and the Caribbean

Carbon pricing is the mechanism designed to capture the external costs of emissions of greenhouse gases (GHG). The price on carbon assigns responsibility for emissions on the emitter and provides an economic incentive to shift towards more clean energy. Selecting the best model is critical for driving innovation and incentivizing transformation in key sectors such as energy and mining to limit climate change. At the most recent Conference of the Parties, several issues relevant to pricing and carbon markets remain in negotiation for the rulebook of the Paris Agreement such as double counting, additionality and upholding rights of local stakeholders.

This session will present the central debates of the international negotiations and present the various carbon pricing models, highlighting the role of national parliaments to assure new economic opportunities for all national stakeholders.
