Following the recent conclusion of the 4th International Conference on Small Island Developing States and its [Gender Equality Forum](#), this virtual meeting will bring together parliamentarians and other actors to outline concrete actions parliamentarians can take to support the achievement of the [SIDS agenda](#). It will also highlight the interconnections between this agenda and two other prominent agreements - the [Bridgetown Initiative 3.0](#) and the [Beijing Declaration and Platform for Action](#) - to emphasize how specific parliamentary actions can contribute to progress on each of these frameworks.

Opening with an interview between The Honourable **Alincia Williams Grant** (Antigua and Barbuda), President of the Senate, and **Tonni Brodber**, Representative of the UN Women Multi-Country Office for the Caribbean, this dialogue will facilitate exploration of the following questions:

- What are the core tenets of the SIDS agenda (drawing especially on outcomes from SIDS4), the Bridgetown Initiative 3.0, and the Beijing Declaration and Platform for Action?
- Why are the three frameworks being considered of particular relevance currently for the region and how do they overlap?
- What are some priority concrete actions that parliamentarians can take to support the implementation of these agreements and why?
- What are some strategies for communicating with our citizens about the importance and benefits of these agreements?

**Open Dialogue: Hazel Brandy-Williams**, Vice-President of CIWiL, will present on the value of multi-stakeholder collaboration for supporting inclusive and effective work by parliamentarians and other actors on the meeting’s themes by highlighting successful examples of these partnerships, before **Nana Oye Hesse-Bayne**, President of CIWiL, moderates a discussion on the themes of this section of the meeting.
