An open parliament undertakes efforts to transform the relationship with the public by promoting transparency, accountability, participation and high ethical standards. It aims to continuously improve how it represents constituents and oversees government actions to lead to better legislative and policy decisions for the country. These efforts are sustained through an institutional and multi-partisan commitment to undergo a continuous parliamentary strengthening exercise, in collaboration with civil society actors and other stakeholders. Open Parliament Action Plans, co-created by parliament and civil society, are an important mechanism that many parliaments have used towards this end.

These parliamentary strengthening initiatives contribute to a larger objective to create more open States and transform government culture to promote innovation and continuously improve policies and service delivery to meet public needs. Parliament is a key actor in this transformation, as many relevant reforms require new legislation or legislative amendments. Through their role of representation and oversight, parliamentarians have a responsibility to promote and engage in public policy issues that affect their constituents.

This meeting will provide an opportunity for parliamentary delegations to exchange with peers, civil society actors and other stakeholders on participative and inclusive practices to identify sustainable solutions to problems that impact citizens' daily lives.

*Openness across all branches of the State can lead to better legislation and public policy that serve citizens' needs and interests. This requires efforts beyond strengthening processes to building an institutional culture in which transparency is key. Parliamentarians need reliable, up to date and accurate information concerning public policy issues at hand to develop evidence-based bills and provide effective oversight of executive actions. Civil society also benefits from openness to strengthen their participation in legislative and public policy issues. This session proposes to explore opportunities through which parliament can leverage the openness agenda to contribute to more informed debates and transformative public policy outcomes. It will also explore emerging challenges, like fake news and disinformation, and consider possible solutions.*
