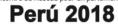

Corruption has differential impacts on women and marginalized groups, which are not always sufficiently recognized or considered in anti-corruption reforms and policymaking. Gender mainstreaming is thus an essential tool for addressing the issue of corruption; and this can likewise help ensure national goals of social and







economic development in accordance with the 2030 Agenda for Sustainable Development are achieved – including women's equal rights and representation in politics. Studies link greater diversity in political representation with numerous positive outcomes including lower perceived levels of corruption. This session will explore the role of women in the anti-corruption agenda as well as multi-partisan and non-partisan mechanisms such as gender caucuses that empower women and center their expertise and experiences in decision-making aimed at improving governance and transforming the conditions that enable corruption to flourish.
