ParlAmericas Parliamentary Delegation to Washington D.C.

March 16-20, 2026 | Washington DC, United States of America

Airports:

The closest airports to Washington D.C. are Washington Reagan National Airport (DCA) and Washington Dulles International Airport (IAD).

Visas:

All participants must have a valid passport (with an expiry date at least six months after the date of travel) and are responsible for obtaining the necessary visas and meeting other entry requirements established by the United States government. It is the responsibility of each participant to consult with the consular authorities of their respective country regarding the entry requirements for the United States and any other countries through which they will transit.

Participants holding official passports from countries in Central America, South America and the Caribbean require a visa to enter the United States.

Protocol:

ParlAmericas is not in a position to offer protocol services for this trip. Delegates are responsible for securing their own transportation to and from the airport in Washington, D.C. Delegates may wish to coordinate directly with their respective embassy or permanent mission for any protocol-related arrangements.

Health Insurance:

Participants are strongly encouraged to obtain international travel health insurance that covers any medical contingencies prior to attending the delegation. It is recommended that those who take special medications travel with their medicines, prescriptions, and any other relevant medical documents.

Participants are also encouraged to verify in advance which medical centers are covered by their insurance policy in order to respond promptly and effectively in the event of any incident. It is likewise advisable to carry an emergency card containing emergency contact information, travel medical insurance information, details regarding any illnesses, allergies, and/or medications being taken, as well as any other relevant information.

ParlAmericas will not be responsible for any financial expenses or other consequences related to the medical care of any participant.

Currency:

Currency exchange for U.S. dollars can be done at the airport in Washington once you have left the customs area.



Electricity:

The electricity supply in Washington is 110 volts. If you bring any equipment that operates on a different voltage, you will need to bring the corresponding adapter.

Dietary Restrictions:

We kindly ask that any dietary restrictions or allergies be communicated as soon as possible.
