Target 5.5: “ensure women’s full and effective participation and equal opportunities for leadership at all levels of decision-making in political, economic, and public life”

A critical look at the SDGs



- 17 Goals
- 169 targets of which only 4 mention indigenous peoples.
- There is not one single specific mention of us as indigenous women.
- Strong weight towards the economic growth approach.
- Lack of recognition of collective rights.
- Lack of recognition of the right to free, prior and informed consent.
- Lack of cultural sensitivity.
- Lack of legal obligation
- Lack of data disaggregated by - cultural identity.

Indigenous women of Peru

- Almost a quarter of the national population (25.7%) is considered indigenous or native.
- Indigenous women are the majority of the indigenous or native population (51.4%) and indigenous or native language is their mother tongue.
- In the access to education an important gender gap is maintained, 13.9% of indigenous women do not reach any grade of primary. Those in Amazonia are the most affected, since 17.4% do not enter school.



Indigenous women of Peru

- In the 2018 provincial municipal elections, 191 indigenous people were elected as councillors, of which only 29 were women.
- In the 2016-2019 period, of 130 elected congressmen, 27% women (36). Only one congresswoman identified herself as indigenous.
- In the prior consultation processes on extractive projects (2013-2018), 29% of attendees were indigenous women.

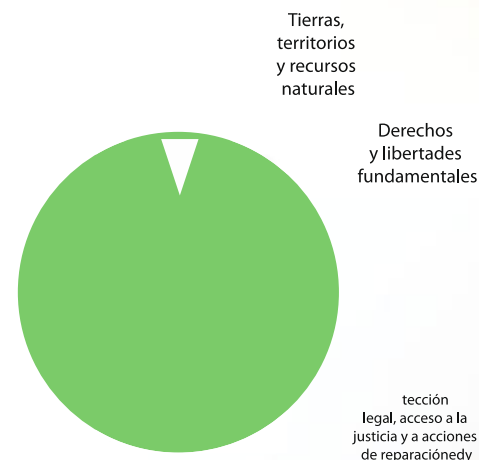




... We also seek to generate data about our reality

- The Indigenous Navigator is a set of tools that supervises the fulfillment of our individual and collective rights.
- Evaluate the level of implementation of our rights at a national and community level.
- They are structured around 13 issues related to the United Nations Declaration on the Rights of Indigenous Peoples.
- More than 1/3 of the SDG targets are linked to the Declaration.
