


ParlAmericas COP26 Communication #1



About COP26

Dates: October 31-November 12

Location: Glasgow, Scotland, United Kingdom

Agendas currently available: The [presidency programme](#) showcasing the main cross-cutting themes of the Conference and the [green zone programme of events](#) (a platform for the general public, managed by the UK government) have been released. The blue zone schedule (UN-managed space which hosts the negotiations) has not been released.

Travelling to COP26

To prepare for your participation, please consult the [immigration and quarantining rules](#) for entering the UK.

[Travel Restrictions](#) for accredited delegates of COP26 as they enter England and Scotland:

- Requirement for unvaccinated individuals that have been in a [red list country](#).¹⁰ days before arriving to the UK to quarantine for the standard 10 days, and a reduced quarantine period of 5 days for fully vaccinated individuals from red list countries*.


- No requirement for self-isolation on arrival to the UK for those [not in the red list of countries](#), whether vaccinated or not.

- The UK Government will fund all required [managed quarantine service](#) stays for UNFCCC Registered COP Attendees (vaccinated or unvaccinated) who would otherwise find it difficult to attend COP26.

* ParlAmericas has sent a communication to the COP26 presidency expressing concern about the inclusiveness COP26, given that quarantine restrictions are imposed on delegates from red-listed countries and territories.
